

## **NCC CONVICTIONS OF THIS PRESENT ADMINISTRATION SINCE 2011**

**Sentencing:**

1. **Fine only:** 18 cases (with N150, 000 being the highest fine imposition)
2. **Imprisonment or the option of fine:** 21 cases (with 2 years being the highest custodial sentence while N250, 000 was imposed as the highest fine option in lieu of 6 months imprisonment).
3. **Imprisonment only or with fine:** 10 cases (ranging from 14 days jail term to 2 years jail term)
